MINUTES OF THE THIRD DAY OF THE SEVENTEENTH GENERAL SYNOD OF THE ANGLICAN CHURCH OF AUSTRALIA HELD IN SYNOD HALL, WANDINY ROOM, NOVOTEL TWIN WATERS RESORT, MAROOCHYDORE ON WEDNESDAY 6 SEPTEMBER 2017

1 SYNOD ASSEMBLED

The Synod reconvened at 8.30 am with the Primate, Archbishop Philip Freier, presiding.

2 PRAYERS

The Synod opened with a service of morning prayer led by the Rev'd Dane Courtney.

The President's Chaplain, the Rev'D Julie Worrall, led the prayer for the General Synod prior to the commencement of business.

3 MINUTES

The minutes of the previous day will be read and confirmed on the resumption of business after the afternoon tea adjournment.

4 ANSWERS TO QUESTIONS

The President gave answers to the following questions:

QUESTION 1

General Synod Bodies Chaired by Women

Dr Leanne Beagley asked:

Whilst I welcome the report on the representation of women across the total 27 General Synod bodies, and note with disappointment that only 3 such committees have equal representation of women I ask:

How many of these committees are chaired by women?

The President gave the following response:

Of the 27 General Synod bodies referred to in the report on the representation of women in Standing Committee's Report to the General Synod, only one body is chaired by a woman.

Justice Debra Mullins is Chair of the Church Law Commission.

QUESTION 2

Appellate Tribunal Referrals

The Rev'd James Warren asked:

Have there been any references to the Appellate Tribunal since their report which appears in Synod papers?

If there have been references what questions have been referred and who requested the Primate to make the referrals?

The President gave the following response:

Three references have been made to the Appellate Tribunal since the publication of the Appellate Tribunal report in Book 2 of the General Synod business papers.

The first was requested by Justice Peter Young, Chancellor of the Diocese of Newcastle, concerning the membership or not of bishop administrators in the House of Bishops. This has been answered and published on the General Synod website.

The second was requested from the Diocese of Newcastle Standing Committee concerning the Affiliated Churches Ordinance of the Diocese of Sydney. This reference had the status of a reference from a Diocesan Synod under section 63 (1) of the Constitution.

The third was requested by the bishops of Bendigo, Bunbury, Gippsland, North Queensland and Willochra in response to the participation of members of the House of Bishops in an episcopal ordination in a church that is not a member of the Anglican Communion.

The text of the questions raised in the second and third matters has been circulated to all Diocesan Bishops, Chancellors and Registrars.

QUESTION 3

Doctrine

Mr Richard Turnbull asked.

Given the reference to doctrine in the business of this General Synod, does the Constitution recognise that at any point in the life of this Church it is possible that the members of the Appellate Tribunal and similarly the members of the House of Bishops may not have a unanimous view about the teaching of this Church on any question of faith.

The President gave the following response:

The Constitution provides that the Appellate Tribunal may make a determination by the majority of its members and bishops, at their consecration or installation as the bishop of a diocese, make the following oath:

"I...... firmly and sincerely believe the Catholic Faith and I give my assent to the doctrine of The Anglican Church of Australia as expressed in the Book of Common Prayer and the Ordering of Bishops, Priests and Deacons and the Articles of Religion, as acknowledged in section 4 of the Constitution, and I believe that doctrine to be agreeable to the word of God.

I declare my assent to the Fundamental Declarations of The Anglican Church of Australia as set out in sections 1, 2 and 3 of the Constitution.

In public prayer and administration of the sacraments I will use the form prescribed in the Book of Common Prayer or a form authorised by lawful authority and none other."

 - ii. convene a national research network to foster the theology and practice of evangelism;
 - iii. examine how community-based chaplaincy and pioneer ministry intersect to create fresh opportunities for mission in a changing society;
 - iv. explore ways to provide for coaching and training support for lay and women pioneer leaders; and
 - v. seek to engage the annual Bishops' Conference in discussion about mission and evangelism in a changing Australia.
