## **Agreed-Upon Procedures in relation to the review of the National Register Canon 2007 and its related protocols ("The Canon")**

We have been engaged by the Standing Committee of General Synod of the Anglican Church of Australia ("the Standing Committee") with the objective of the engagement to provide findings of the processes and procedures in relation to the administration of the National Register ("the Register") are in compliance with the Canon.

We have performed procedures agreed with you to report factual findings for the purpose of assisting you in assessing, in combination with other information obtained by you, that the policies and procedures are in compliance with the Canon for the period 1 January 2021 to 31 December 2021. Our procedures have been carried out based on the requirements of the identified separate clauses within the Canon. The procedures performed are detailed in the terms of the engagement of 16 March 2022 and described below and in the attached appendix.

### *Management's Responsibility for the Procedures Agreed*

Management are responsible for the adequacy or otherwise of the procedures agreed to be performed by us. You are responsible for determining whether the factual findings provided by us, in combination with any other information obtained, provide a reasonable basis for any conclusions which you or other intended users wish to draw on the subject matter.

### *Assurance Practitioner's Responsibility*

Our responsibility is to report factual findings obtained from conducting the procedures agreed. We conducted the engagement in accordance with Standard on Related Services ASRS 4400 *Agreed-Upon Procedures Engagements to Report Factual Findings*. We have complied with ethical requirements equivalent to those applicable to Other Assurance Engagements, including independence.

Because the agreed-upon procedures do not constitute either a reasonable or limited assurance engagement in accordance with AUASB standards, we do not express any conclusion and provide no assurance on the compliance with the Canon. Had we performed additional procedures or had we performed an audit or a review of the policies and procedures to ensure compliance with the Canon in accordance with AUASB standards, other matters might have come to our attention that would have been reported to you.



Requirements of the National Register Canon 2007	Factual findings
<p><b>Clause 4 of the National Register Canon 2007</b></p> <p>There shall be a National Professional Standards Register of clergy and lay persons established and maintained in accordance with the provisions of this Canon.</p> <p><b>Work performed to address the above Clause</b></p> <p>We reviewed the National Professional Standards Register to ensure that it is regularly maintained.</p> <p>We reviewed the access log to ensure that the Register is only accessible by authorised persons.</p>	<p><b>Factual findings</b></p> <p>Through audit enquiry and observation, we documented the design of the National Professional Standards Register (“the Register”) system. We sighted the existence of a National Register.</p> <p>The current full register exists on a secure web portal that has access restricted to persons who are authorised to do so. Each user has a unique username and password before entering a different entry code each time they log on, received via The Microsoft Authenticator Application.</p> <p>New information can be uploaded to the Register via the web portal, and this ability is restricted to the Directors of Professional Standards (“DPS”). There are 16 DPS’s (2020: 18). When new information is uploaded to the portal, the DPS’s are able to hold the information on a sub-level before uploading to the register. This sub-level database is only accessible to other DPS’s in other Diocese around Australia. When the DPS is ready to upload an event, the item is uploaded directly on to the register. This report only relates to the Register, not the DPS sub-ledger.</p> <p>The system automatically sends a message to the National Register Officer (“NRO”) who will then send a notification to the member of the clergy or lay person concerned.</p> <p>Information regarding persons on the register can be accessed via the following methods:</p> <ul style="list-style-type: none"> <li>Each of the 16 DPS’s (2020:18) and 28 additional authorised users (2020: 26) have access to the Register portal. Authorised Users can access information through the submission of an ‘Application for authorised Diocesan persons to access the National Register Report Request System’.</li> </ul> <p>This is located on the Anglican Church website at:  <a href="https://www.anglican.org.au/national-register">https://www.anglican.org.au/national-register</a></p> <ul style="list-style-type: none"> <li>▪ Any other member of the clergy or layperson can request details regarding own information on the register by completing an ‘Application to Obtain Information about Yourself in the National Register’ form also available at the above website.</li> </ul>

	<ul style="list-style-type: none"> <li>▪ It is the responsibility of the NRO to confirm that the identity of each applicant has been verified by a Justice of Peace or equivalent (e.g. Notary) before information is disclosed.</li> <li>▪ Persons who have information on the Register can apply to make amendments or remove information by completing the 'Application for Amendment of Information in the National Register' which is also on the website.</li> </ul> <p>We note that during the 2021 year, there were 12 new and 12 removals / resignations of authorised users.</p> <p><b>Limitation in assessing compliance with relevant clause</b></p> <p>None</p>
<p><b>Clause 5 (1) of the National Register Canon 2007</b></p> <p>The National Register shall be a register of all clergy:</p> <p>a) against whom a notifiable complaint or a notifiable charge has been made unless it is exhausted; or</p> <p>b) in respect of whom there has been a relinquishment of, or consent to deposition from, Holy Orders arising out of sexual misconduct or child abuse; or</p> <p>c) who have made an adverse admission or are the subject of an adverse finding; or</p> <p>d) in respect of whom there has been an adverse check or an adverse criminal history check or an adverse Safe Ministry Check; or</p>	<p><b>Factual findings</b></p> <p>Testing was performed with the NRO in connection to the composition of information on the register, and examined documentation to determine if the information on the register has been recorded in accordance with Clause 5(1). The system allows the user to drill down in to the individual name and review all information uploaded by the DPS on the screen.</p> <p>The register contains information relating to clergy, including:</p> <ul style="list-style-type: none"> <li>▪ given names,</li> <li>▪ date of birth,</li> <li>▪ postal address,</li> <li>▪ notifiable complaints or charges that have been placed against them,</li> <li>▪ which authorised user has requested information on persons on the register.</li> </ul> <p>Of the twenty three (23) Diocese, we received eighteen (18) responses to the confirmations that were sent. Fifteen (15) of these confirmed they were in compliance, and three (3) were not in compliance. There were no response from 5 of the Diocese.</p>

Sixteen (16) of these confirmed they were in compliance, and two (2) were not in compliance. There were no response from 5 of the Diocese.</p> <p><b>Limitation in assessing compliance with relevant clause</b></p> <p>There is an inherent limitation of scope in testing the completeness of the Register in relation to ‘all lay persons’. Seventeen (17) of these confirmed they were in compliance, and one (1) was not in compliance. There were no response from 5 of the Diocese.</p> <p>We found that the Register retained details of when information relating to the lay-persons was last updated/altered, however, as in the previous year it was noted that several individuals on the Register did not have known dates of birth or postal addresses.</p>

	<p><b>Limitation in assessing compliance with relevant clause</b></p> <p>There is an inherent limitation of scope in testing the completeness of the Register in relation to 'all lay persons'. This is due to limitations of evidence that all DPS's have updated the Register for <b>all</b> reportable complaints and notifications that they are aware of, as we are unable to track all complaints and notifications made to the DPS.</p>
<p><b>Clause 7 (1) of the National Register Canon 2007</b></p> <p>Subject to this Canon, the National Register shall be maintained by the General Secretary in such form as the Standing Committee shall approve so as to ensure the security of the Information therein.</p> <p><b>Work performed to address the above Clause</b></p> <p>Through enquiry and observation with the NRO, we documented the security systems of the National Register.</p> <p>As part of the process, we also received updated information from the IT support team.</p> <p>We also documented the key IT upgrades that were made during the year.</p>	<p><b>Factual findings</b></p> <p>On enquiry and observation, we found that the Register has been developed into a system that is able to record information about clergy and lay persons in accordance with the scope provided by the Canon. We found that the system has the following security measures to protect the information therein:</p> <p><i>Storage of information</i> – Data is stored within the Web Portal. Access to this is restricted only to those with authority granted by the NRO. To access the online database, the users must enter a secure online portal, using an individuals username, passwords and pass codes that change with each entry (received via a text message).</p> <p><i>Security of data</i> – The online portal used in the Register system is hosted by an enterprise level hardware Dell Sonicwall SRA4600, which is protected by Firewalls and is further secured through layers of privileges and authentication for users. We note that the firmware for the firewall was updated on 8/7/21 and 9/12/21 as communicated by Infocom.</p> <p><i>Upload of Information</i> – Information is only able to be uploaded onto the server by a DPS through the access within the online portal. No other users are able to upload information onto the database.</p> <p>When a DPS makes an application to or a modification of the Register onto the server, an automatically generated internal message is sent to the NRO. This is to ensure the NRO is aware of all new information uploaded.</p>

	<p><i>Access of Information</i> – Access of information can be requested by each of the active DPS’s, along with 28 additional ‘Authorised Users’ (e.g. non DPS’s). Each authorised user must fill out and have approved (by the NRO) an ‘Application for Authorisation’ which is available on <a href="https://www.anglican.org.au/national-register">https://www.anglican.org.au/national-register</a> to obtain access to information in the database. Once the form is appropriately filled, the Diocesan Bishop will confirm the validity of the individual by counter signing the form. Once fully signed and approved by the Bishop, the new user is sent a guide pack on how to access the online portal.</p> <p>In addition, any member of the clergy or laity can access own information held on the Register by completing an “Application for own information” also available on the website, however information will only be made known to those whose identities are confirmed by a Justice of the Peace or equivalent and verified by the NRO.</p> <p><b>Limitation in assessing compliance with relevant clause</b></p> <p>We note that whilst we obtained and documented the security systems, we have not tested the effectiveness and sufficiency thereof.</p>
<p><b>Clause 7 (2) of the National Register Canon 2007</b></p> <p>The General Secretary shall issue forms necessary for the operation of the National Register and publish these forms on the website of the General Synod.</p> <p><b>Work performed to address the above Clause</b></p> <p>We reviewed the National Registry website and enquired with the NRO to ensure that the necessary documents have been provided to ensure that authorised users and clergy/lay persons have access to the above information as per Clause 7.</p>	<p><b>Factual findings</b></p> <p>Reviewed the <a href="https://www.anglican.org.au/national-register">https://www.anglican.org.au/national-register</a> website and documented the forms available relating to the Register.</p> <p>We found that the following approved forms allowed users to access the following information on the Register:</p> <ul style="list-style-type: none"> <li>▪ Application for Authorised Diocesan Persons to Access the National Register Report Request System</li> <li>▪ Application to Obtain Information About Yourself in the National Register</li> <li>▪ Application for Amendment of Information in the National Register.</li> </ul> <p><b>Limitation in assessing compliance with relevant clause</b></p> <p>None</p>

<p><b>Clauses 8 (1), (2) and (4) of the National Register Canon 2007</b></p> <p>A DPS shall enter 'Information' in the National Register relating to any member of the clergy or lay person to which he or she has access in carrying out his or her responsibilities, in accordance with a protocol approved by the General Synod, or the Standing Committee, and as soon as practicable and, no later than one month after he or she has access to the Information.</p> <p>DPS shall advise General Secretary if information of which he or she is aware, has not been entered as soon as practicable.</p> <p>DPS who has given advice to General Secretary per Clause 8 (2) will as soon as practicable notify General Secretary of this information.</p> <p><b>Work performed to address the above Clauses</b></p> <p>We sent confirmation letters to all the DPS's representing the 23 Diocese requesting positive confirmation that they complied with the above requirements.</p>	<p><b>Factual findings</b></p> <p>Of the twenty three (23) Diocese, we received eighteen (18) responses to the confirmations that were sent. Thirteen (13) of these confirmed they were in compliance, and five (5) were not in compliance. There were no response from 5 of the Diocese.</p> <p><b>Limitation in assessing compliance with relevant clause</b></p> <p>Due to the limitations in access to evidence from authorised persons and each church authority, we were unable to confirm if the notifications from the DPS had been sent "as soon as practicable and no later than one month" after they had access to the information.</p>
<p><b>Clause 8 (3) of the National Register Canon 2007</b></p> <p>The General Secretary shall:</p> <ul style="list-style-type: none"> <li>a) after receipt of advice, promptly enter a caution in the National Register in relation to the member of the clergy or lay person, the subject of that Information; and</li> <li>b) no later than one month after the entry of that caution in the National Register, notify the member of the clergy or lay person</li> </ul>	<p><b>Factual findings</b></p> <p>A 'caution' is a notice of information not yet confirmed as a notifiable complaint within the specified timeframe.</p> <p>The NRO confirmed that they had not been made aware of any cautions required to be recorded during the 2021 year.</p>

<p><b>Clause 8 (5) of the National Register Canon 2007</b></p> <p>The General Secretary shall promptly after the earlier of:</p> <ul style="list-style-type: none"> <li>a) notification by a DPS under subsection (4); and</li> <li>b) the expiration of two months from receipt of a request in writing from the member of the clergy or lay person the subject of the caution requesting its removal, remove the caution from the National Register.</li> </ul> <p><b>Work performed to address the above Clause</b></p> <p>We enquired of the NRO as to whether there were any cautions and incidents.</p> <p>We reviewed the register to identify any cautions and incidents.</p>	<p><b>Factual findings</b></p> <p>The NRO confirmed that they had not been made aware of any cautions required to be recorded during the 2021 year.</p> <p><b>Limitation in assessing compliance with relevant clause</b></p> <p>Due to the limitations to access of information, we were unable to confirm that there were no such instances.</p>

Requirements of the National Register Canon 2007	Factual findings
<p><b>Clause 9 (1) of the National Register Canon 2007</b></p> <p>Subject to subsection (5), the General Secretary shall, as soon as practicable, and no later than one month, after the entry of Information in the National Register relating to a member of the clergy or a lay person (other than a changed entry relating to item 4 of each of the First and Second Schedules), notify the member of the clergy or lay person concerned of the entry of that Information by letter sent to his or her last known postal or electronic address where that address is known.</p> <p><b>Work performed to address the above Clause</b></p> <p>We reviewed the interpretation of Clause 9 in regards to notification requirements when information is added or updated for persons already in the register.</p> <p>We obtained the statistics of new additions to the Register from the NRO.</p> <p>For all new additions to the register:</p> <ul style="list-style-type: none"> <li>• We verified that a notification was sent to the last known postal or electronic address;</li> <li>• We verified that a letter was sent as soon as practicable, but no later than one month; and</li> <li>• A registered post stamp date matched the date in the system.</li> </ul>	<p><b>Factual findings</b></p> <p>There were 20 (2020: 26) persons added to the register and 28 (2020: 36) events added for the 2021 calendar year.</p> <p>We tested all 20 additions in the current year. We confirmed that letters sent out to the member of the clergy or lay person were sent to their last known postal or electronic address as soon as practicable. This is sent either Registered Post or by email.</p> <p>We verified that the letters were sent out within one month of being added to the register, with no exceptions noted.</p> <p>There were four (5) instances where the last address was unknown (2020: 4) and therefore, no letter of notification could be sent.</p> <p><b>Limitation in assessing compliance with relevant clause</b></p> <p>From a review of Clause 9, it was noted that the NRO has a requirement to notify existing persons “after the entry of Information in the National Register” regardless of whether the person has previously been notified of their inclusion on the register.</p> <p>From a review of processes and previous discussions with the General Secretary, it was noted that the NRO does not notify existing persons when modifications are made to their existing events or if an additional event is added to their name. This is because the NRO does not have access to the details of the event which has been added or amended and has determined it not appropriate to send out a new notification in these instances. It is also understood that that it was not the intention of the clause to be constantly updating the persons with every minor change to the register. We have not performed any work in this regard.</p>

<p><b>Clause 9 (5) of the National Register Canon 2007</b></p> <p>Where the General Secretary receives a police request, or a police request record from a DPS, the General Secretary shall not notify the member of the clergy or lay person of the entry of Information in the National Register relating to that person until the sooner of:</p> <ul style="list-style-type: none"> <li>▪ the expiration of six months after the receipt of the police request; or</li> <li>▪ the receipt of a withdrawal of the police request; and</li> <li>▪ a withdrawal of the police request record from a Director of Professional Standards, as the case may be.</li> </ul> <p><b>Work performed to address the above Clause</b></p> <p>We discussed with the NRO regarding the compliance with Clause 9(5).</p> <p>We enquired about the status of police requests made during the year and open cases at year end.</p> <p>We reviewed the statistics detailing the persons and events added to the year to identify all police requests.</p> <p>For active cases, we traced the cases of police requests to the additions made to the Register.</p> <p>We ensured that where a case is still under police request, there has been no notification sent to the member.</p>	<p><b>Factual findings</b></p> <p>From inquiries with the NRO and review of the persons and events added to the National Register in 2021, there were 4 new police requests made during the year (2020: 0).</p> <p>It was noted that two (2) police requests existed at the end of the prior year (2020) and these were tested in the 2020 audit to determine compliance of the Clause 9(5).</p> <p>It was noted that, of the two (2) police flags that existed at the end of the prior year, two (2) were removed during the 2021 year, and a total of four (4) outstanding requests relating to 2021 existed at year-end.</p> <p><b>Limitation in assessing compliance with relevant clause</b></p> <p>None.</p>
