Special Session of General Synod – Saturday 26 July 2025

3 April 2025 - Circular 01

To all General Synod Members

The General Synod Standing Committee has requested the Primate to convene a special session of General Synod to consider the *Bill for the General Synod Presence (Amendment) Canon 2025*.

This will be the only item of business to be considered during the session. Arrangements for a Special Session of Synod do not provide the opportunity to propose additional legislation and motions as would occur at an ordinary session of synod.

The Bill is in response to the following resolution relating to accessible participation in General Synod sessions which was passed at the Eighteenth Session of General Synod in 2022.

Resolution GS 93/18

That this Synod requests the Standing Committee to develop the reasonably required measures, including legislation, to enable greater accessible participation, including online and in-person attendance in meetings of the General Synod, particularly by persons unable to attend or participate physically in, such meetings by reasons such as disability, disease or illness, medical condition or injury and that any legislation required be presented to a special session of General Synod, held by video conference, at least one year before the next ordinary session of General Synod.

The General Synod Standing Committee has received advice that the issues raised in the resolution can be addressed by amendments to the *General Synod Presence Canon 2022*.

The Special Session will commence at 11.00 am AEST. It is expected to conclude at 3.00 pm AEST or when the business has concluded.
